Moline Education Association Association Representatives Meeting Tuesday, April 12th, 2016

The MEA Association Representatives met Tuesday, April 12th, 2016, at the IEA Office, Moline. President Susie Hafner called the meeting to order at 3:47pm. There were 16 representatives and 10 Executive Board members in attendance. There was no quorum present.

Treasurer Mary Nelson reported balances in all accounts. It was voted (January 2015) to not publish the dollar amounts in the MEA budget in neither the minutes nor the Monitor. Members with questions regarding the MEA account balances are asked to contact Treasurer Mary Nelson.

Committee Chair Reports:

- Membership Heidi Norcross reported membership stands at 437.
- Elections in the absence of Doug Bodeen, President Hafner reminded members that election forms for MEA Executive Board positions were due to Doug Bodeen by Friday, April $15^{\rm th}$.
- Legislative Dave Strafford explained the process for the IEA endorsement of legislators. The recommendation meeting for endorsements will be in June; Dave will provide more information when received. Members may receive a Call to Action from IEA; members were encouraged to contact their legislators in response to the Call to Action. The Representatives Assembly is April 13th April 16th in Chicago.
- Region 18 no report.
- Public Relations no report.
- Social Aubree Savage reported the committee is planning a May event.
- Grievance/Negotiations Colette Guerdet encouraged members to involve the Grievance Committee as soon as possible in the case of a possible grievance.

Old Business:

- President Hafner had received positive feedback regarding the Superintendent meeting with the special education teachers.

New Business:

- Copies of the proposed 2016-2017 MEA Budget were distributed to the ARs.
- President Hafner informed members of the April $25^{\rm th}$ deadline for the MEA Scholarships. Updated forms will be available on the MEA blog.

- Christine Watts informed members that teams would be writing the new elementary curriculum units this summer and would also discuss what resources would be needed for the new units. Grade level chairs will bring the information to Allendale administration in the fall, where the money amount for each grade level will then be determined. Allendale is allocating the money so that it is consistent throughout the district.
- President Hafner reported that Scheduling/Teams/Co-Teaching is an on-going discussion. Superintendent McGuire will inform building principals to be aware of the guidelines in the MEA contract found on page 15.
- President Hafner informed members of the possible three open positions on the Board of Education next spring. It was noted that with the change in insurance premiums for retired teachers, retired teachers who change to TRIP would be eligible to run for BOE positions.
- President Hafner encouraged all ARs to attend the May meeting in order to vote on proposed By Law changes and MEA budget. The Social committee will provide food and door prizes.
