## **AR Secretary's Report - Emily Roberts**

Moline Education Association Association Representatives Meeting Thursday, May 12<sup>th</sup>, 2016

The MEA Association Representatives met Thursday, May 12<sup>th</sup>, 2016, at the IEA office, Moline. In the temporary absence of President Susie Hafner, Vice-President Christine Watts welcomed and thanked Sue Krismanits, a member of the MEA Scholarship Committee, who then announced and introduced the recipients of the 2015-2016 MEA Scholarships: Emmy Ehlers, daughter of Scott and Mary Ehlers, and Jordan Polito, daughter of Lisa Polito. Emily Ehlers told the ARs of her plans to attend the University of Iowa, majoring in education. Jordan Polito was unable to attend due to a conflict, so Lisa Polito told the ARs of Jordan's plans to attend Mount Mercy College, planning to become an orthopedic surgeon.

President Hafner called the meeting to order at 3:50pm. There were 26 ARs and 8 Executive Board members in attendance; a quorum was present.

A motion was made by Colette Guerdet, seconded by Kim Anderson, to approve the minutes of the February  $11^{th}$ , 2016, March  $10^{th}$ , 2016, and April  $12^{th}$ , 2016, AR meetings. **Motion** passed.

Treasurer Mary Nelson reported balances in all accounts. A motion to approve the treasurer's report was made by Sherri Martin, seconded by Heidi Norcross. **Motion** passed. It was voted (January 2015) to not publish the dollar amounts in the MEA budget in neither the minutes nor the Monitor. Members with questions regarding the MEA account balances are asked to contact Treasurer Mary Nelson.

#### Committee Chair Reports:

- Membership Heidi Norcross reported membership stands at 437.
- Elections in the absence of Doug Bodeen, President Hafner accepted MEA election ballots and reminded ARs of the ballot return date.
- Legislative no report.
- Region 18 Scott Ehlers reported a meeting scheduled for May 13<sup>th</sup>.
- Public Relations Kim Anderson reported that 75 blank Years of Service pins had been ordered.
- Social Tina Ferreri reminded ARs of the social event scheduled for Friday, May 13<sup>th</sup>, 3:30pm, at the Barrelhouse, Moline.
- Grievance/Negotiations Colette Guerdet asked members to forward any ideas for contract negotiations to her.

#### Old Business:

- Colette Guerdet read and explained the proposed Bylaw change for the creation of an MEA Audit Committee under Article XI: Committees. A motion to approve the Bylaw change was made by Kim Anderson, seconded by Sherri Martin. **Motion** passed.
- Colette Guerdet read and explained the proposed Bylaw change for the clarification of wording under Grievance/Negotiations, Article II, section 3. A motion to approve the Bylaw change was made by Heidi Norcross, seconded by Tricia Leibovitz. **Motion** passed.
- Treasurer Mary Nelson distributed copies and discussed the proposed 2016-2017 MEA budget. A motion to approve the proposed budget was made by Colette Guerdet, seconded by Liz Finch. **Motion** passed.
- Elementary Resources Vice-President Christine Watts explained to ARs that after curriculum units are completed, a list of resources would be presented at the first 2016-2017 grade level meeting. After group discussion, the grade level chairs will take the

prioritized resources lists to Allendale. Purchase money for the resources will be distributed through the curriculum office at Allendale.

- President Hafner and Colette Guerdet met with Superintendent Lanty McGuire and building principals and discussed scheduling/teams/co-teaching and meeting the MEA contract guidelines. Colette Guerdet reminded the ARs to contact her the first day of the 2016-2017 school year if there are any concerns or violations.
- President Hafner reminded ARs of the need to find good candidates for the three possible vacancies on the Board of Education.

#### A.R. Concerns:

- It was voted (2010-2011) to not publish AR concerns in the Monitor. ARs were reminded to communicate concerns discussed at the meeting with the other MEA members they represent. President Hafner will discuss most issues in the "President's Corner" section of the Monitor or send superintendent's responses directly to the ARs for dissemination to members.

There being no further business, a motion to adjourn was made by Colette Guerdet, seconded by Heidi Norcross. **Motion** passed. The meeting adjourned at 4:37pm.
