### **AR Secretary's Report - Emily Roberts**

Moline Education Association Association Representatives Meeting Thursday, September 13th, 2018

The MEA Association Representatives met Thursday, September 13<sup>th</sup>, 2018, at the IEA office, Moline. President Susie Hafner called the meeting to order at 3:50pm. There were 22 ARs and 11 Executive Board members in attendance; a quorum was present.

A motion was made by Jill Bogart, seconded by Debbie Sturges, to approve the minutes of the April 12<sup>th</sup>, 2018, and May 10<sup>th</sup>, 2018, AR meetings. **Motion** approved.

Treasurer Steve Sundberg reported balances in all accounts. A motion to approve the treasurer's report was made by Sherri Martin, seconded by Heidi Norcross. **Motion** passed. It was voted (January 2015) to not publish the dollar amounts in the MEA budget in neither

the minutes nor the Monitor. Members with questions regarding the MEA account balances are asked to contact Treasurer Steve Sundberg.

A motion was made by Rachel Moore, seconded by Jamie Kovacic, to approve the proposed 2018-2019 MEA budget. **Motion** passed.

President Susie Hafner yielded the floor to Treasurer Steve Sundberg. Treasurer Sundberg read the names of the appointed Committee Chairs: Membership – Heidi Norcross; Elections – Lori Wesemann and Val Hays; Legislative – Dave Strafford; Public Relations – Kim Anderson; Social – Aubree Krol and Tina Ferreri; Grievance/Negotiations – Colette Guerdet and Susie Hafner. A motion was made by Jen Sondgeroth, seconded by Sherri Martin, to approve the appointed Committee Chairs. **Motion** passed.

President Susie Hafner resumed the floor.

### Committee Chair Reports:

- <u>Membership</u> Heidi Norcross and Steve Sundberg will be taking an Association Day to process membership forms and member count. Heidi explained that members would sign the new blue form for payroll deduction only once in their career; in the future, only new hires will sign the blue form.
- **Elections** Lori Wesemann reported there would be two upcoming elections.
- Legislative no report.
- Region 18 no report.
- <u>- Public Relations</u> Kim Anderson reported that the MEA40.org blog includes archived Monitors, AR expectations, and a list of ARs and Executive Board members. She asked members send her any good news to be included on the blog. The Years of Service pins and certificates were delivered to buildings via the principals; anyone inadvertently missed on a pin or certificate is asked to contact Kim.
- <u>- Social</u> Aubree Krol announced a there would be a drawing for Whitey's gift cards at the end of the meeting, and an MEA fall social event was being planned.
- **Grievance/Negotiation** no report.

#### **Old Business:**

- President Hafner shared some results of the technical survey sent to teachers last spring.
- President Hafner reported that there were no changes to the salary schedule as of this time.
- As a result of the Janus decision, non-union teachers should be aware that if an incident occurs that is not covered within the language of the MEA contract, the non-union teacher will be without union representation and legal aid.

#### **New Business:**

- President Hafner reported there had been good discussion with the curriculum council regarding vertical alignment as a professional development session at the January in-service.
- President Hafner noted that the district took a positive step in hiring new classroom teachers in order to reduce class size. She informed the ARs that a course of action was being planned where a group of four to five new teachers would not receive pink slips in the spring; rather, they would be guaranteed a job somewhere in the district. The hope is to reduce the lengthy process now in place to hire classroom reduction teachers.
- President Hafner noted that this was Superintendent Lanty McGuire's last year of service. The district hired a consulting firm for a superintendent search; the plan is to approve a new superintendent by the January Board of Education meeting. President Hafner has asked a select, diverse, group of teachers to be part of a focus group for the superintendent search.
- President Hafner reported that the salary statements should be forthcoming and reminded members to check the employee portal.
- President Hafner noted that, due to the Janus decision, a conservative group (anti-union) had sent a FOIA request to the district for access to Executive Board members e-mails; she noted this request was being made to school districts all over the state of Illinois.

#### A.R. Concerns:

- It was voted (2010-2011) to not publish AR concerns in the Monitor. ARs were reminded to communicate concerns discussed at the meeting with the other MEA members they represent. President Hafner will discuss most issues in the "President's Corner" section of the Monitor or send superintendent's responses directly to the ARs for dissemination to members.

There being no further business, a motion to adjourn was made by Lisa Welvaert, seconded by Kim Anderson. **Motion** passed. The meeting adjourned at 4:22pm.
