The MEA Association Representatives met via Google Meets on Thursday, March 10th, 2022. President Susie Hafner called the meeting to order at 3:52pm. There were 23 ARs and 13 Executive Board members in attendance; a quorum was present.

A motion was made by Marlene Delong, seconded by Liz O'Hern, to approve the minutes of the February 10th, 2022, AR meeting. **Motion** approved.

Treasurer Steve Sundberg reported balances in all accounts. A motion to approve the treasurer's report was made by Christine Watts, seconded by Heidi Norcross. **Motion** approved. It was voted (January 2015) to not publish the dollar amounts in the MEA budget in neither the minutes nor the Monitor. Members with questions regarding the MEA account balances are asked to contact Treasurer Steve Sundberg.

Committee Chair Reports:

- Membership Heidi Norcross reported membership stands at 487.
- Elections In the absence of chair Marigrace Alonso, President Hafner reported that Lori Wesemann and Raya Knight will be the delegates to the NEA Convention.
- Legislative no report.

- Public Relations Kim Anderson reported the MEA scholarship form was available on the MEA blog. 200 Years of Service pins will be engraved (10-30 years), with a cost of \$5.00 set-up fee, \$0.50 per pin, plus tax.

A motion was made by Karri Dies, seconded by Lisa Welvaert, to approve the minutes of the January 13th, 2021, AR meeting. **Motion** approved.

Treasurer Steve Sundberg reported balances in all accounts. A motion to approve the treasurer's report was made by Marlene Delong, seconded by Trisha Leibovitz. **Motion** approved. It was voted (January 2015) to not publish the dollar amounts in the MEA budget in neither the minutes nor the Monitor. Members with questions regarding the MEA account balances are asked to contact Treasurer Steve Sundberg.

Committee Chair Reports:

- Membership no report.
- Elections Marigrace Alonso reported that the election for delegates to the NEA Convention and Region Council Offices positions will be held March 2nd, 2022.
  Ballots will be available next week. MEA had one nomination - Lori Wesemann.
- Legislative -Raegan Jones reported that Governor Pritzker vetoes bill 2778. The compromise was an agreement between the IEA and the governor that only fully vaccinated staff could receive their sick days back if out due to COVID. SB3689 is a potential bill that would adjust and fix Tier 2. It would change the age and year requirement as well as adjust the salary.
- Region 18 no report.
- Public Relations -Kim Anderson reported that the setup fee is \$5, the engraving cost per pin is 50 cents per pin. If we get 200 pins engraved, that would be \$5+(0.50x200)=\$105 plus 7% tax would be \$112.35. That will leave 100 blanks yet to engrave at a future date. - Social Sarah Dembosky drew names for \$5 QC Fuel gift cards. The winners were Steve Sundberg, Karri Dies, Kara Banfield, Liz O'Hern, and Rachel Moore.
- Grievance/Negotiations no report.

Old Business:

- President Hafner reported that the donation to Moline Baseball in memory of Derek Lindauer was sent off.
- President Hafner reported that the snow day is intended to be low stress for both students and teaches.
- The BOE passed a substitute incentive that will begin second semester. A substitute teacher will receive a \$300 bonus for every 20 days worked.

New Business:

- President Hafner reported that insurance rates do go up every calendar year, so the increase in rates took place in January 2022. Our insurance fund is headed in the right direction. There are a handful of 55-65 year old retirees still on our plan, and there are 5 retirees over 65 that are also on our insurance plan.
- Sarah Dembosky informed the group that you can get your prescriptions mailed to you through Walgreens.
- President Hafner reported that she had spoken with district administration about the wearing of masks with the recent court ruling. The district is planning on staying the course for now until the appeals process is completed. If a student refuses to wear a mask, have them sit 6 feet away from other students. If they continue to cause a distraction, treat it like any other behavior issue.
